Final Order Entered: 1. The rates and charges proposed by Shelby Energy are denied. 2. The rates and charges, as set forth in Appendix B to this Order, are approved as fair, just and reasonable rates for Shelby Energy, and these rates and charges are approved for service rendered on and after the date of entry of this Order. 3. Shelby Energy shall file revised Tariff Sheets Nos. 222 and 245 to clarify that customers with AMI meters are not subject to the Reconnection Service fee of \$35 and the Meter Testing fee of \$32.50. Tariff Sheet No. 223 shall be removed from its tariff as the fee is no longer assessed. 4. The remaining tariff changes proposed by Shelby Energy are approved. 5. Within 20 days of the date of service of this Order, Shelby Energy shall file with the Commission, using the Commission's electronic Tariff Filing System, its revised tariffs, setting out the rates, charges, and modifications approved or as required herein and reflecting that they were authorized pursuant to this Order. 6. Shelby Energy shall complete and submit a depreciation study prior to filing its next application for a streamlined or general rate adjustment. The depreciation study shall include an evaluation of both Distribution and General Plant assets. 7. This case is closed and removed from the Commission's docket.
