Cure deficiencies: Address all deficiencies listed above and provide justification for revenue sufficiency as required under 807 KAR 5:078 Sections 8(3)(a) and in furtherance of KRS 278.030; or c. Withdraw Application: Notify the Commission, in writing, if it elects not to proceed. 3. The statutory or administrative processing deadlines for Cumberland Valley Electric's application pursuant to 897 KAR 5:078 shall not begin until such time an application has been accepted for filing. 4. The Attorney General shall be allowed to file comments within seven days, if and when, Cumberland Valley Electric chooses to refile its application curing deficiencies pursuant to 807 KAR 5:078.
