The customer notice shall contain the information set forth in the Appendix to this Order. 4. Muhlenberg District shall provide proof of publication of the notice to the Commission no later than 30 days from the date of this Order. 5. If the Commission does not receive any written requests for intervention or a hearing in this matter within 30 days of publication of new rates, this case shall stand

If Commission Staff recommends that Muhlenberg District's financial

condition supports a higher rate than Muhlenberg District proposes or the assessment of an additional rate or charge not proposed in Muhlenberg District's application, Muhlenberg District in its response to the Commission Staff's Report shall also state its position in writing on whether the Commission should

authorize the assessment of the higher rate or the additional rate or charge.
