The Commission shall open a separate proceeding, Case No. 2025-00397, to investigate whether North McLean District Commissioner, Dale Chandler, failed to attend the required 12-hour new commissioner training within 12 months of his appointment as required by KRS 74.020(8) and to determine if a vacancy exists on North McLean District's board of commissioners as a result. 5. Within 20 days of the date of service of this Order, North McLean District shall file with this Commission, using the Commission's electronic Tariff Filing System, new tariff sheets setting forth the rates and charges approved herein and their effective date, and stating that the rates and charges were authorized by this Order. 6. This case is closed and removed from the Commission's docket.
