A verbal announcement made by the presiding officer shall be proper notice of the continued hearing. 4. Witnesses who sponsored schedules, testimony, or responses to requests for information shall participate in person at the August 12, 2025 hearing. 5. Navitas KY shall give notice of the hearing to all customers in compliance with 807 KAR 5:001, Section 9(2)(b). In addition, the notice of hearing shall include the following statements: "This hearing will be streamed live and may be viewed on the PSC website, psc.ky.gov" and "Public comments may be made at the beginning of the hearing.
