The Gas Cost Adjustment applicable to a customer who is receiving service under Rate Schedule GS or IUS and received service under Rate Schedule SVGTS shall be \$5.5175 per Mcf only for those months of the prior 12 months during which they were served under Rate Schedule SVGTS.
