05/14/25 Final Order Entered: 1. McKinney District is granted a CPCN for Phase 1A of the proposed project as submitted. 2. McKinney District's proposed plan of financing is approved. 3. McKinney District is authorized to enter into a loan in the amount of \$855,000 with RWFA, anticipated to mature over a period of 18.71 years and with an expected interest rate of 4.56 percent. 4. The proceeds of the loans shall be used only for the purposes specified in McKinney District's application. 5. McKinney District shall obtain approval from the Commission prior to performing any additional construction not expressly authorized by this Order. 6. McKinney District shall file with the Commission documentation of the total costs of this project, including the cost of construction and all other capitalized costs (e.g., engineering, legal, and administrative), within 60 days of the date that construction is substantially completed. Construction costs shall be classified into appropriate plant accounts in accordance with the Uniform System of Accounts for water utilities prescribed by the Commission. 7. McKinney District shall notify the Commission in writing one week prior to the actual start of construction.
