The proposed facility consists of a tower not to exceed 265 feet in height, with attached antennas, to be located on the west side of Capp Springs Road (County Road 1115), approximately 0.8 mile north of US HWY 68, Benton, Kentucky 42025. The coordinates for the proposed facility are North Latitude 36° 51' 47.91" by West Longitude 88° 14' 55.18". 2. Joint Applicants shall immediately notify the Commission in writing if, after the antenna tower is built and utility service is commenced, the tower is not used for three consecutive months in the manner authorized by this Order. 3.
