06/02/25 Final Order Entered: 1. Northern Kentucky District is granted a CPCN for Phase 3 and Phase 4 of the Northern Kentucky District water main replacement project, as proposed in its application. 2. Northern Kentucky District shall immediately notify the Commission upon knowledge of any material changes to the projects, including but not limited to increase in cost and any significant delays. 3. Any material deviation from the construction approved by this Order shall be undertaken only with prior approval of the Commission. 4. Northern Kentucky District shall file with the Commission documentation of total costs of the projects, including the cost of construction and all other capitalized costs (e.g., engineering, legal, administrative, etc.) within 60 days of the date that the construction authorization under this CPCN is substantially completed. Construction costs shall be classified into appropriate plant accounts in accordance with the Uniform System of Accounts for water utilities prescribed by the Commission. 5. Northern Kentucky District shall file a certified statement that the construction has been satisfactorily completed in accordance with the construction plans and specifications within in 60 days of the substantial completion of the construction discussed herein. 6. Northern Kentucky District is authorized to issue the evidence of debt requested subject to the conditions set forth in its application and discussed herein.

The Commission may amend the procedural schedule as necessary, including to permit filing of intervenor testimony, if intervenors are joined. 3. Northern Kentucky District shall respond to all requests for information propounded by Commission Staff, whether identified on the procedural schedule or otherwise, as provided in those requests. 4.
