The residual surcharge of \$4.5000 per Mcf is approved for service rendered on and after January 1, 2026, subject to refund, until further Order of the Commission to cease collecting the residual surcharge or up to of December 31, 2027, whichever occurs sooner. 2. Navitas KY shall maintain its records in such a manner as will enable it, the Commission, and any of Navitas KY's customers, to determine the amounts to be refunded and to whom any refund is due in the event that a refund of any portion of the GCR or residual surcharge is ordered by the Commission. 3. Navitas KY shall file monthly reports to the Commission detailing: (1) The record of the total amounts recovered through this residual surcharge; (2) the total amount of remaining debt owed to each natural gas supplier and transporter serving Kentucky customers; (3) the amount paid to each natural gas supplier and transporter serving Kentucky customers; (4) the usage report for the month; and (5) proof of payment to each natural gas supplier and transporter serving Kentucky customers to which debt is owed. 4. The GCR component charges and credits applied by Navitas KY, through its GCR mechanism, as proposed, beginning with usage on and after November 2, 2025, through January 31, 2026, for Case No. 2025-00316, is accepted.

04/30/25	Order Entered: 1. This proceeding is established to investigate the reasonableness of the proposed GCR rates. 2. Navitas KY NG's proposed GCR rates are suspended for one day, to May 2, 2025. 3. Navitas KY NG's proposed GCR rates may be placed in effect by Navitas KY NG on, or after May 2, 2025, pending the final Order in this matter and subject to refund, provided Navitas KY NG files written notice to the Commission of its intention to do so as required by KRS 278.190(2). 4. If Navitas KY NG files notice of its intention to place the proposed GCR rates into effect after the end of the suspension period, Navitas KY shall maintain its records in such manner as will allow it, the Commission, or any customer to determine the amounts to be refunded and to whom in the event of a refund is ordered upon final resolution of this matter. 5. The procedural schedule set forth in the Appendix to this Order shall be followed. 6. Navitas KY NG shall respond to all requests for information propounded by Commission Staff, whether identified on the procedural schedule or otherwise, as provided in those requests.
