All parties shall respond to the Commission Staff's first Request for Information, attached as Appendix C, by the date set forth in the request. 5. Within seven days of the service date of this Order, counsel shall enter an appearance or appearances. 6. Pursuant to 807 KAR 5:001, Section 8(9), within seven days of service of this Order, all utilities providing electric service shall file a written statement with the Commission that: a. Certifies that it, or its agent, possesses the facilities to receive electronic transmissions; and b. Sets forth the electronic mail address to which all electronic notices and messages related to this proceeding shall be served. 7.
