On or before the date set forth in the procedural schedule, McCreary District shall file its responses to the Commission Staff's request for information, attached to this Order as Appendix B. 3. McCreary District shall respond to any additional requests for information propounded by Commission Staff as provided in those requests. 4. No later than the date set forth in the procedural schedule, Commission Staff shall file with the Commission and serve upon all parties of record a written report (Commission Staff's Report) containing its recommendations regarding McCreary District's requested rate adjustment. 5. No later than 14 days after the date of service of the Commission Staff's Report, each party of record shall file with the Commission: a. Its written comments on and any objections to the findings contained in the Commission Staff's Report; and b. Any additional evidence for the Commission to consider. 6. If Commission Staff recommends that McCreary District's financial condition supports a higher rate than McCreary District proposes or the assessment of an additional rate or charge not proposed in McCreary District's application, McCreary District in its response to the Commission Staff's Report shall also state its position in writing on whether the Commission should authorize the assessment of the higher rate or the additional rate or charge.
