East Casey District's proposed credit/debit card payment provision is approved for service rendered on and after June 1, 2025. 3. East Casey District's proposed change to the customer bill due date is suspended for five months from June 1, 2025, up to and including October 31, 2025. 4. Within 20 days of the date of service of this Order, East Casey District shall file a revised tariff sheet reflecting the Commission's approval of the credit/debit card payment provision and reflecting its effective date and that it was authorized by this Order. 5. East Casey District shall, by counsel, enter an appearance in this proceeding within seven days of the date of service of this Order.
