The Rider PMM rates in the Appendix to this Order are approved for service rendered on and after the date of service of this Order. 4. Duke Kentucky's request to create a regulatory asset for the expenses related to this project that exceed the five percent cap is approved. 5. Within 20 days of the date of service of this Order, Duke Kentucky shall file with the Commission, using the Commission's electronic Tariff Filing System, new tariff sheets setting forth the rates, charges, and modifications approved or as required in this Order, and reflecting their effective date and that they were authorized by this Order. 6. In all future CPCN and Rider PMM cases related to the AM07 project, Duke Kentucky shall be required to provide estimates and actuals with the corresponding case numbers and phase numbers on all charts. Furthermore, a specific breakdown of actual costs incurred shall be included in the Rider PMM cases. 7. Duke Kentucky shall provide a detailed explanation as to the reasons for the excess costs if the actual costs exceed ten percent of the estimated cost, regardless of the section of the project. 8. This case is closed and removed from the Commission's docket.
