12/08/25 Final Order Entered: 1. Kentucky Power's request to submit this case for a decision on the existing evidence of record without a hearing is granted. 2. Kentucky Power's determination that it had no additional over- or under recovery for the review period is accepted. 3. Kentucky Power shall use a weighted average cost of capital of 6.79 percent, a tax gross-up factor of 1.339896, a return on equity rate of 9.65 percent, and an overall grossed-up return of 8.16 percent in all monthly environmental surcharge filings subsequent to the date of this Order. 4. The environmental surcharge amounts determined by Kentucky Power for the two-year billing period ending June 30, 2025, are just and reasonable. 5. This case is closed and removed from the Commission's docket.
