03/17/26 Final Order Entered: 1. The rates proposed by Valley Gas are denied. 2. The rates set forth in the Appendix B to this Order are approved for service rendered on and after April 1, 2026. Valley Gas shall submit all invoices it receives along with its monthly usage reports for each month of the reporting period when it files its future GCR rate reports. 3. Valley Gas shall set out its RA as (\$0.8082) per Mcf for the next 36 months or until \$81,123.71 has been credited to customers. 4. Valley Gas shall submit all invoices it receives along with its monthly usage reports for each month of the reporting period when it files its future GCR rate reports. 5. Valley Gas shall maintain its records in such a manner as will allow Valley Gas, and the Commission, to determine the amounts of gas costs recovered through Valley Gas's GCR rate mechanism. 6. Should Valley Gas purchase sustainable natural gas from a renewable source during the reporting period of any future GCR reports, then the supplier, cost, and amount shall be documented in its cover letter to the Commission.

If Valley Gas files notice of its intention to place the proposed GCR rates into effect after the end of the suspension period, Valley Gas shall maintain its records in such manner as will allow it, the Commission, or any customer to determine the amounts to be refunded and to whom in the event a refund is ordered upon final resolution of this matter.
