05/20/26 Final Order Entered: 1. Jackson Purchase Energy's proposed plan of financing is approved. 2. Jackson Purchase Energy is authorized to execute the \$10 million PowerVision Loan with CFC as provided. 3. Jackson Purchase Energy is authorized to increase its MDL on its Mortgage from \$200 million to \$250 million. 4. Jackson Purchase Energy is authorized to increase its CFC LOC from \$5 million to \$10 million. 5. Jackson Purchase Energy is authorized to change its CFC LOC from a revolving LOC to a perpetual LOC. 6. The proceeds of the financings shall be used only for the purposes specified in Jackson Purchase Energy's application. 7. Jackson Purchase Energy shall file with the Commission the final terms and agreement of the PowerVision Loan. 8. Any documents filed in the future pursuant to ordering paragraph 6 of this Order shall reference this case number and shall be retained in Jackson Purchase Energy's post-case correspondence file. 9. The Executive Director is delegated authority to grant reasonable extensions of time for filing of any documents required by this Order upon Jackson Purchase Energy's showing of good cause for such extension. 10. This case is closed and removed from the Commission's docket. Nothing contained in this Order shall be deemed a warranty of the Commonwealth of Kentucky, or any agency thereof, of the financing, herein approved.
