| 12/27/07 | Order entered: (1) Southeast Daviess is granted CPC&N; (2) SD shall assess surcharge of \$0.39 per 1,000 gallons to all customers for a period not to exceed 60 months or until KIA loan as been retired in full, whichever occurs first; (3) Within 20 days of date of Order, SD shall file revised tariff sheets; (4) SD shall list surcharge as separate line item on each bill; (5) If construction not commenced within 5 years, SD shall refund all surcharge proceeds with all interest & earnings; (6) SD shall set proceeds in a separate interest bearing reserve trust account; (7) SD shall maintain records to determine amounts to be refunds and to whom in event that surcharge amounts shall be refunded; (8) SD shall obtain Commission approval prior to performing any additional construction; (9) Any deviation from construction shall be undertaken only with prior approval of Commission; (10) SD shall furnish documentation of total costs of project within 60 days of substantial completion of construction; (11) SD shall require inspection under general supervision of professional engineer (12) SD shall file copy of "as-built" drawings; (13) In 2008, and thereafter in which surcharge effective, SD shall submit written reports; (14) At end of 60 mos. or retirement of KIA loan, SD shall revise its tariff to reflect termination of surcharge; (15) SD financing is approved; (16) SD is authorized to enter in proposed loan agreement with KIA. |
