- (1) Powell's Valley's application for rehearing is granted.
- (2) Powell's Valley shall no later than May 28, 2009 file with the Commission the original and six copies of the information listed in the appendix, with a copy to all parties of record.
- (3) Motions for extensions of time with respect to the schedule shall be made in writing and will be granted only upon a showing of good cause.
- (4) All documents that this Order requires to be filed with the Commission shall be served upon all other parties.
- (5) To be timely filed with the Commission, a document must be received by the Commission within the specified time with the date the transmitting agency received said document from the sender noted by the transmitting agency on the outside of the container used for transmitting, within the time allowed for filing.
- (6) Service of any document or pleading shall be made in accordance with 807 KAR 5:001, Section 3(7), and Kentucky Civil Rule 5:02.

- (1) The recommendations and findings contained in the Staff Report are adopted and incorporated by reverence into this Order.
- (2) Powell's Valley shall have 45 days from the date of this Order to implement an accounting system as recommended by Staff and shall have an additional 15 days to provide documentation to the Commission that an adequate accounting system has been implemented.
- (3) Within 14 months form the implementation of the new accounting system, Powell's Valley shall file a written request with the Commission for Staff assistance in performing a limited financial review.
- (4) Powell's Valley's proposed water rates, which are set forth in the Appendix, are approved for service rendered by Powell's Valley on and after the date of this Order.
- (5) Within 30 days of the date of this Order, Powell's Valley shall file with the Commission its revised tariff setting out the rates approved herein.

02/03/09 Order Entered 02/03/09:

- (1) This proceeding is established to investigate the reasonableness of Powell's Valley's proposed water service rate.
- (2) All parties have 14 days from the date of this Order to submit to the Commission written comments, if any, regarding the Staff Report and to request a hearing or an informal conference in this matter.
- (3) Any party requesting a hearing shall state in its request its objections to the findings set forth in the Staff Report and provide a brief summary of testimony.
- (4) A party's failure to object to a finding or recommendation contained in the Staff Report within 14 days of this Order shall be deemed as agreement with that finding or recommendation.
- (5) If no request for hearing or informal conference is received within the 14 days, this case shall stand submitted to the Commission for decision.
