| | (1) Fleming Water is granted a Certificate of Public Convenience and Necessity. |
| | (2) Fleming Water's proposed plan of financing with RD is accepted. |
| | (3) Fleming Water is authorized to issue its Waterworks Revenue Bonds from the RD loan in the amount of \$375,000 at an interest rate not exceeding five percent per annum maturing over 40 years. |
| | (4) The proceeds from the loan agreement with RD shall be used only for the purposes specified in Fleming Water's application. |
| | (5) Notwithstanding Ordering Paragraph 4, if surplus funds remain after the approved construction has been completed, Fleming Water may use such surplus to construct additional plant facility if RD approves of the use. |
| | (6) Fleming Water shall file a copy of the "as-built" drawings and a certified statement that the construction has been completed within 60 days of the substantial completion of the construction. |
| | (7) Fleming Water shall monitor the adequacies of the expanded water distribution system after construction. |
| | (8) Fleming Water shall notify the Commission one week prior to the actual start of construction and at the fifty percent completion point. |
| | (9) The rates set out in Appendix A are approved for service rendered on and after the date of this Order. |
| | (10) Within 30 days of the date of this Order, Fleming Water shall file with the Commission its revised tariffs. |
