 (2) A party's failure to object to a finding or recommendation within 14 days shall be deemed as agreement.  
 (3) No later than 14 days, each party shall notify the Commission in writing whether this matter may be submitted for decision based upon existing record and without hearing.  
 (4) No later than 14 days, a party may request an informal conference.  
 (5) Unless all parties request this matter be submitted for decision upon the existing record, a formal hearing shall be held on July 15, 2011 at 9:00 a.m. in Hearing Room 1 of the Commission's offices.  
 (6) Center Ridge shall publish notice of the hearing in accordance with 807 KAR 5:011, Section 8(5) and shall file proof of publication with the Commission no later than July 14, 2011.
