Within 20 days of the date of this Order, Pendleton District shall file revised tariff sheets with the Commission setting forth the rates approved in this Order 4. Pendleton District shall for accounting and ratemaking purposes use a service life of 75 years for transmission and distribution mains when calculating and reporting depreciation for all reporting periods after the date of this Order, but shall make no retroactive adjustment to its books to account for the cumulative effect of this change in accounting estimate.

2. No later than November 15, 2012, Commission Staff shall file with the Commission and serve upon all parties of record a written report containing its findings and recommendations regarding Pendleton District's requested rate adjustment.
3. The parties shall file with the Commission their written comments on, and any objections to, the findings and recommendations contained in the Commission Staff Report no later than November 29, 2012, or 14 days after the date of the filing of the Commission Staff Report, whichever occurs earlier. Any party may file with such submission any additional evidence for the Commission's consideration.
4. A party's failure to file written objections to a finding or recommendation contained in the Commission Staff Report by 11/29/12, or 14 days after the date of the filing of the Commission Staff Report, whichever occurs earlier, shall be deemed as agreement with that finding or recommendation.
5. No later than 11/29/12, or 14 days after the date of the filing of the Commission Staff Report, whichever occurs earlier, each party shall notify the Commission in writing whether this matter may be submitted far decision based upon the existing record without hearing.
