- 6. Any future increases to basic local exchange rates necessitated by the FCC's ICC/USF Order shall be filed as an application in compliance with Commission regulations.

The estimated annual revenue to be lost due to adjustment of terminating access rates effective July 1, 2013. The total estimated annual revenue (increase or decrease) to be generated by the tariff changes. Include a breakout for each service or category of service to show changes in revenue d. Historical and projected line counts and the effects of any line changes on the company

e. Historical and projected federal universal service support and its effects on the company. f. A narrative of any other circumstances that justify or support the proposed rate changes.
