Order Entered: (1) On page 4, the second sentence under the heading Allocation of Roll-in is amended by correcting the case number to read as follows: That Order authorized the use of the methodology previously approved in the Settlement Agreement in Case No. 2011- 00162. (2) On page 4, footnote number 9 is amended by correcting the case style to read as follows: Case No. 2011-00162, Application of Louisville Gas and

Electric Company for Certificates of Public Convenience and Necessity and Approval of its 2011 Compliance Plan for Recovery by Environmental Surcharge (Ky. PSC Dec. 15, 2011). - 1. LG&E's request to submit this case for a decision on the existing evidence of record without a hearing is granted.
- 2. The environmental surcharge amounts determined by LG&E for the review period ending April 30, 2013, are just and reasonable.
- 3. In the second full billing month following the month in which the Commission issues its Final Order in this proceeding, LG&E shall increase its

jurisdictional environmental revenue requirement by \$389,127 for one month.

- 4. LG&E shall roll \$13,088,937 of incremental environmental surcharge amounts found to be just and reasonable herein into its existing base rates, for a total base rate environmental component of \$13,883,368. The roll-in shall be allocated to the customer classes as described in the Settlement Agreement approved in Case No. 2011-00161 and in Case No. 2011-00232.
- 5. LG&E shall use an overall rate of return on capital of 7.14%, a return-on-equity rate of 10.25%, a tax gross-up factor of 0.64, and an overall grossed-up return of 10.26% in all monthly environmental surcharge filings subsequent to the date of this Order.
- 6. Within 20 days of the date of this Order, LG&E shall file with the Commission revised tariffs reflecting the changes to its base rates as a result of the roll-in of environmental surcharge amounts described herein; the same type of supporting documentation it filed in Case No. 2011-00232; other proposed language changes described herein; and a red-lined version of its tariffs.
