No later than August 15, 2015, Farmers RECC shall file with the Commission an ESAP evaluation report for the six months ending June 30, 2015, that includes the number and type of energy-efficient appliances for which rebates were paid, the amount of the rebates, the amount paid to the owner-member, and the projected kWh energy savings.
