requirements of 807 KAR 5:006, Section 26(4)(e), are inapplicable to its 34.5-kV and 46-kV electric line facilities and that these facilities are instead subject to the ground-inspection requirements of 807 KAR 5:006, Section 26(4)(c), is denied. 2. Kentucky Power's request for a declaration that, to the extent that it complies with the ground-inspection requirements of 807 KAR 5:006, Section 26(4)(c), with respect to its electric lines operating at or above 69 kV, it may make the inspections required by 807 KAR 5:006, Section 26(4)(b)4 aerially is granted. 3. Kentucky Power's request for a deviation from the inspection requirements of 807 KAR 5:006, Section 26(4)(e), for its 34.5-kV and 46-kV electric line facilities is denied. 4.
