No later than April 29, 2016, or 14 days after the date of the filing of the Commission Staff Report, whichever occurs earlier, each party of record shall file with the Commission: a. Its written comments on and any objections to the findings and recommendations contained in the Commission Staff Report; and b. Any additional evidence for the Commission to consider. 3. If a party requests a hearing or informal conference, then the party shall make the request in its written comments and state the reason why a hearing or informal conference is necessary. 4. If Commission Staff finds that Wood Creek's financial condition supports a higher rate than Wood Creek proposes or the assessment of an additional rate or charge not proposed in Wood Creek's application, Wood Creek in its response to the Commission Staff Report shall also state its position in writing on

whether the Commission should authorize the assessment of the higher rate or the recommended additional rate or charge.
