The materials for which Foothills Rural Telephone seeks confidential treatment shall not be placed in the public record or made available for public inspection for a period of five years from the date of this Order, or until further Order of this Commission. 3. Use of materials in question in this proceeding shall be in compliance with 807 KAR 5:001, Section 13(9). 4. Foothills Rural Telephone shall inform Commission if materials in question become publicly available or no longer qualify for confidential treatment. 5. If a non-party to this proceeding requests to inspect materials granted confidential treatment by this Order and the period during which the materials have been granted confidential treatment has not run, Foothills Rural Telephone shall have 20 days from receipt of written notice of the request to demonstrate that the materials still fall within the exclusions from disclosure requirements established in KRS 61.878. If Foothills Rural Telephone is unable to make such demonstration, the requested materials shall be made available for inspection. 6. The Commission shall not make the requested materials available for inspection for 20 days following an Order finding that the materials no longer qualify for confidential treatment in order to allow Foothills Rural Telephone to seek a remedy afforded by law. Otherwise, the Commission shall deny the request for inspection.
