EKPC's motions for confidential protection for its responses to the requests for information contained in the Appendix to the Commission's Order dated August 12, 2016; its responses to Staff's First Request, Item 15; and its responses to Staff's Post Hearing Request, Item 5, are granted. 2. The designated materials shall not be placed in the public record or made available for public inspection for ten years, or until further Orders of this Commission. 3. Use of the designated materials in any Commission proceeding shall be in compliance with 807 KAR 5:001 , Section 13(9). 4.
