Neither opening statements nor summaries of pre-filed testimony will be permitted. 2. Not less than 7 days and no more than 21 days prior to the scheduled hearing, Duke Kentucky shall publish, in a newspaper of general circulation in each area in which it serves, notice of the purpose, time, place, and date of the scheduled hearing. In addition, the notice of hearing shall include the following statement: "This hearing will be streamed live and may be viewed on the PSC website, psc.ky.gov." 3. Duke Kentucky shall file with the Commission no later than October 8, 2018, proof of publication of its notice for the hearing. 4. The official record of the proceeding shall be by digital video recording only. 5. a. The information requested in the Appendix to this Order is due no later than 14 days from the date of entry of this Order.
