Green River Valley District is authorized to issue Waterworks Revenue Bonds in the amount of \$8,062,000, consisting of \$5,600,000 of Series A Bonds and \$2,462,000 of Series B Bonds, maturing over a period not to exceed 40 years with an interest rate not to exceed 2.25 percent per annum for the Series A Bonds and at an interest rate not to exceed 2.75 percent per annum for the Series B Bonds that will be purchased by USDA/RD. 4. The proceeds from the promissory note shall be used only for the purposes specified in Green River Valley District's application. 5. Green River Valley District is authorized to obtain a grant in the amount of \$3,563,000 from USDA/RD. 6. Green River Valley District shall obtain approval from the Commission prior to performing any additional construction not expressly authorized by this Order.
