The proceeds from the water revenue bonds shall be used only for the purposes specified in Bronston Water's application. 5. Bronston Water shall obtain approval from the Commission prior to performing any additional construction not expressly authorized by this Order. 6. Notwithstanding ordering paragraphs 4 and 5, if surplus funds remain after

authorized by this Order. 6. Notwithstanding ordering paragraphs 4 and 5, if surplus funds remain afte the approved construction has been completed, Bronston Water may use such surplus to construct

additional plant

facilities if USDA/RD approves of the use and the additional construction, and it will not result in a change in Bronston Water's rates for service. Bronston Water shall provide written notice of this additional construction in accordance with 807 KAR 5:069, Section 4.
