Kentucky-American, in all future QIP filing applications, shall include detailed, supporting documentation justifying how Kentucky-American develops its scope of work and cost estimates for each project, including an itemized breakdown for material, labor, and paving and reasoning for each variance from the original estimate. 4. Within 20 days of the date of this Order, Kentucky-American shall, using the Commission's electronic Tariff Filing System, file its revised tariffs setting out the rates authorized in this Order and the revised QIP Rider and reflecting they were approved pursuant to this Order. 5. This case is now closed and removed from the Commission's docket.
