08/07/25 Final Order Entered: 1. Western Pulaski District is granted a CPCN to replace water lines as proposed in the application. 2. Western Pulaski District shall immediately notify the Commission upon knowledge of any material changes to the projects, including but not limited to increase in cost and any significant delays. 3. Any material deviation from the construction approved by this Order shall be undertaken only with prior approval of the Commission. 4. Western Pulaski District shall file with the Commission documentation of total costs of the projects, including the cost of construction and all other capitalized costs (e.g., engineering, legal, administrative, etc.) and a certified statement that the construction has been satisfactorily completed in accordance with the construction plans and specifications within 60 days of the date that the construction authorization under this CPCN is substantially completed. Construction costs shall be classified into appropriate plant accounts in accordance with the Uniform System of Accounts for water utilities prescribed by the Commission. 5. Western Pulaski District shall notify the Commission in writing one week prior to the actual start of construction, and again once the construction authorized under this CPCN is 50 percent completed. 6. Western Pulaski District shall file a copy of the loan documents executed with KIA in this matter within ten days of executing them.
