Pursuant to KRS 278.020(1)(a), Arcadia Pines, Carriage Park, Marshall Ridge, and Randview are granted a Certificate of Public Convenience and Necessity to provide utility service to and for the public. 2. Bluegrass Water's Application of Commission approval of acquisition of certain wastewater systems is granted. 3. The initial rates proposed by Bluegrass Water are approved. 4. Within ten days of completion of the transfer of Arcadia Pines, Carriage Park, Marshall Ridge, and Randview to Bluegrass Water, Bluegrass Water shall notify the Commission in writing of the date that each transfer occurred. 5. One month after the closing of the transaction, Bluegrass Water shall file for each of the acquired systems a report listing discharge quality, number of service interruptions, employee or contractor response times, and any violations or citations for the preceding month. 6. Six months after the closing of the transaction, Bluegrass Water shall file for each of the acquired systems a report listing discharge quality, number of service interruptions, employee or contractor response times, and any violations or citations for preceding month. 7. One year after the closing of the transaction, Bluegrass Water shall file for each of the acquired systems a report listing discharge quality, number of service interruptions, employee or contractor response times, and DOW violations or citations for preceding month. |
