The monthly water rates for Phase 2 set forth in Appendix B of the September 13, 2022 Order are effective for bills issued on and after December 1, 2023, which bill for service rendered on and after the billing cycle that begins on October 2, 2023, with meters read on November 1–2, 2023. 3. Big Sandy District's requests for rehearing on approval of phased-in rates and to use the surcharge proceeds on projects set forth in Big Sandy District's application are denied. 4. Big Sandy District's request to amend the effective dates established in the September 28, 2022 Order for phase 1 and phase 2 monthly water rates is granted for the limited purpose of Big Sandy District providing additional information regarding the service periods, meter reading dates, and bill issuance dates applicable to Big Sandy District's proposed effective dates. 3. Big Sandy District's request to amend the effective date of the nonrecurring charge is granted in part and denied in part. Big Sandy District's request to amend the effective date of the nonrecurring charge is granted only to the extent that the nonrecurring charge and phase 1 monthly water rates shall have the same effective date.
