As there is no line loss adjustment for direct served customers. shall deduct 6.39 mills per kWh from the base energy rate applicable to its direct served customer 3. The rates in the Appendix to this Order are approved for service rendered on and after June 1,2011, the effective date of East Kentucky's change in rates. 4.
