Final Order Entered: (1) NKWD is granted a Certificate to proceed with the proposed construction as set forth in its application. (2) NKWD shall notify the Commission prior to performing any additional construction. (3) Any deviation from the construction shall be undertaken only with prior approval of the Commission. (4) NKWD shall file a copy of the "as-built" drawings and a certified statement by a professional engineer that the construction has been satisfactorily completed in accordance with the contract plans and specifications within 60 days of the substantial completion of the construction. (5) NKWD shall require construction to be inspected under the general supervision of a licensed engineer with KY registration in civil or mechanical engineering to ensure construction work is done in accordance with the contract drawings & specifications and with best practices of construction trades involved in the project. (6) Within 30 days of its Board of Commissioners' final decision on the selection of a contractor for proposed project, NKWD shall file with Commission a certified copy of the board resolution or minutes evidencing that decision. Should NKWD's Board select a contractor other than the contractor who submitted the lowest bid, NKWD shall also submit a written explanation for the Board of Commissioners' action. (7) Any documents filed pursuant to ordering paragraphs 4 & 5 shall reference this case number be retained in the utility's general correspondence file.
