Olive Hill shall pay \$5,000 of the \$60,000 assessed civil penalty within 30 days of the date of this Order by cashier's check or money order payable to the Kentucky State Treasurer, and mailed or delivered to the Office of the General Counsel, Kentucky Public Service Commission, 211 Sower Boulevard, Post Office Box 615, Frankfort, Kentucky 40602. The remaining \$55,000 of the civil penalty shall be suspended on the condition that Olive Hill complies with the ordering paragraphs 3, 4, and 5 of this Order within the timeframe allowed. 3. Within 30 days of the date of this Order, Olive Hill shall replace the main that is exposed in Tygart's Creek with a new main installed under the creek so that the pipeline is protected from washouts, floods, unstable soil, landslides, or other hazards that may cause the pipeline to move or sustain abnormal loads. 4. Olive Hill shall provide the Commission written notice within 5 days of the commencement of construction to replace the section of pipeline exposed in

Tygarts Creek. 5. Olive Hill shall provide the Commission written notice within 5 days of completion of

construction to replace the section of pipeline exposed in Tygarts Creek.
