		Report for the period January 1, 2017, through the date of the transfer. 7. Any documents filed
		pursuant to ordering paragraphs 2, 3, and 6 shall reference this case number and shall be retained in
		Farmdale Development's general correspondence file. 8. The Executive Director is delegated authority
		to grant reasonable extensions of time for the filing of any documents required by this Order upon a
		showing of good cause for such extension.
