The meter test results for all meters tested as part of this project shall be reported to the Commission on Cumberland Valley's Quarterly Meter Report and shall include a full explanation of any billing adjustments resulting from the tests. 7. Cumberland Valley shall depreciate the new AMI system over a 15-year period.
