No later than October 25, 2018, Commission Staff shall file with the Commission and serve upon all parties of record a written report (Staff Report) containing its findings and recommendations regarding Southern District's requested rate adjustment. 3. No later than 14 days after the date of the filing of the Staff Report, each party of record shall file with the Commission: a. Its written comments on and any objections to the findings contained in the Staff Report; and b. Any additional evidence for the Commission to consider. 4. If Commission Staff finds that Southern District's financial condition supports a higher rate than Southern District proposes, or the assessment of an additional rate or charge not proposed in Southern District's Application, Southern District, in its response to the Staff Report, shall also state its position in writing on whether the Commission should authorize the assessment of the higher rate or the additional rate or charge. 5. If Commission Staff finds that changes should be made to the manner in which Southern District accounts for the depreciation of Southern District's assets,

Southern District in its response to the Staff Report shall also state its position in writing on whether the Commission should require Southern District to implement the proposed change for accounting purposes.
