Keith Gutterman shall pay one thousand two hundred fifty dollars (\$1,250) within thirty (30) days of the date of this Order by cashier's check or money order payable to the Kentucky State Treasurer and mailed or delivered to the office of the Kentucky Public Service Commission at 211 Sower Boulevard, Frankfort, KY 40602. 3. As a first time violator of the Act, Keith Gutterman is eligible for mitigation of penalty as established by the Division of Inspections informal policy and past practice by making a payment of one hundred dollars (\$100) and attending a damage prevention training course to be held at the offices of the PSC at 211 Sower Boulevard, Frankfort, Kentucky on April 6, 2020 at 1:00 p.m. If Keith Gutterman attends the above training course and on or before that date pays a civil penalty in the amount of one hundred dollars (\$100), the additional one thousand two hundred fifty dollars (\$1,250) assessed against him in numerical paragraph 2 will be vacated. THIS IS A FINAL AND APPEALABLE ORDER OF THE PUBLIC SERVICE COMMISSION.
