The rates in the Appendix to this Order are approved effective with service rendered on and after August 1, 2021. The rates in the Appendix to this Order are designed to reflect the decrease of \$0.00239 per kWh to base energy rates, which is the differential between

the old base fuel cost of \$0.02851 per kWh and the new base fuel cost of \$0.02612 per kWh. 5. Beginning with the expense month for August 2021, Kentucky Power shall use a FAC rate based upon a base fuel cost of \$0.02612 per kWh. 6. Within 20 days of the date of this Order, Kentucky Power shall file, using the Commission's electronic Tariff Filing System, its revised tariff sheets with the Commission setting out the rates approved herein and reflecting that they were approved pursuant to this Order. 7.
