05/26/23 Order Entered: 1. Duke Kentucky's proposed Rider PMM rates are denied. 2. The Rider PMM rates in the Appendix to this Order are approved for service rendered on and after June 1, 2023. 3. The first sentence in the Rate section of Duke Kentucky's Rider PMM tariff shall be amended to read as follows: Customers shall be assessed a surcharge or credit to enable the Company to recover costs associated with compliance with regulations promulgated by the U.S. Department of Transportation Pipeline and Hazardous Materials Administration, as approved by the Kentucky Public Service Commission. 4. Duke Kentucky's Rider PMM rate for 2023 shall be trued-up in the 2025 Rider PMM rate as discussed above. 5. Duke Kentucky shall file Rider PMM rates in volumetric format for the 2024 calendar year. 6. Within 20 days of the date of service of this Order, Duke Kentucky shall file with the Commission, using the Commission's electronic Tariff Filing System, new tariff sheets setting forth the rates, charges, and modifications approved or as required in this Order, and reflecting their effective date and that they were authorized by this Order. 7. This matter is closed and removed from the Commission's docket.
