AMENDMENT TO THE COMMERCIAL AGREEMENT BETWEEN WHOLESALE CARRIER SERVICES, INC. AND

BELLSOUTH TELECOMMUNICATIONS, LLC D/B/A AT&T KENTUCKY, INDIANA BELL TELEPHONE COMPANY INCORPORATED D/B/A AT&T INDIANA, SOUTHWESTERN BELL TELEPHONE COMPANY D/B/A AT&T OKLAHOMA

This Amendment to the Commercial Agreement ("Amendment") is entered into by and between Wholesale Carrier Services, Inc. (referred to as "CARRIER"), and BellSouth Telecommunications, LLC d/b/a AT&T KENTUCKY, Indiana Bell Telephone Company Incorporated d/b/a AT&T INDIANA, Southwestern Bell Telephone Company d/b/a AT&T OKLAHOMA ("AT&T"). AT&T and CARRIER are hereinafter referred to collectively as the "Parties" and individually as a "Party".

WHEREAS, CARRIER and AT&T are Parties to certain Commercial Agreement pursuant to which AT&T provides Transit Traffic Service ("Transit Traffic Service Agreement") dated August 20, 2013 and as subsequently amended (the "Agreement"); and

NOW, THEREFORE, AT&T and CARRIER agree to amend the Commercial Transit Traffic Service Agreement as follows:

- 1. This Amendment is composed of the foregoing recitals, the terms and conditions, set forth below, all of which are hereby incorporated in this Amendment by this reference and constitute a part of this Amendment.
- 2. This Amendment removes the following state(s) from the CARRIER's Terms and Conditions as well as the Appendix Pricing for the purchase of Transit Traffic Service in the state(s) of Indiana, Kentucky and Oklahoma. AT&T will provide Transit Traffic Service under the terms of the Interconnection Agreement between CARRIER and AT&T under Sections 251 and 252 of the Communications Act of 1996 ("Interconnection Agreement") subject to Section 3 below.
- This Transit Traffic Service Agreement for Indiana, Kentucky and Oklahoma shall terminate on the date the transit rates go into effect pursuant to the approval by the Commission(s) of the applicable transit traffic amendment to the Interconnection Agreement.
- 4. The Parties agree to add Sections 18.1.3 and 18.2.5:
 - 18.1.3 delivered by electronic mail (email) provided CARRIER and/or <u>AT&T-18STATE</u> has provided such information in Section 18.3 below.
 - 18.2.5 notice by email shall be effective on the date it is officially recorded as delivered by delivery receipt and in the absence of such record of delivery, it shall be presumed to have been delivered on the date sent to CARRIER by <u>AT&T-18STATE</u>.
- 5. The Parties agree to replace Section 18.3 with the following:
