On July 13, 2012, the Public Service Commission filed the following proposed regulations with the Legislative Research Commission:

- 807 KAR 5:001 – Rules of Procedure
- 807 KAR 5:006 – General Rules
- 807 KAR 5:011 – Tariffs
- 807 KAR 5:076 – Alternative Rate Adjustment Procedure for Small Utilities

LRC requested that revisions be made to the original filings in order to conform to its drafting rules.

All four amendments have been published in the August 1, 2012 edition of the Administrative Register of Kentucky.

A public hearing on the proposed amendments will be held on August 27, 2012 at 9:00 a.m., Eastern Time, at the Commission's offices at 211 Sower Boulevard in Frankfort, Kentucky.

Anyone that wishes to attend the hearing should submit a notice of intent to attend to the Commission no later than August 20, 2012.

If no one files a notice of intent to attend by the deadline, the Commission may cancel the hearing.

Any written comments on the proposed amendments must be submitted no later than August 31, 2012.
