O R D E R

On March 21, 1977, the Commission issued its Order in the above-styled Case, authorizing, among other items, adjusted rates to be placed into effect upon the conversion of Logan Rural Telephone Cooperative Corporation (Applicant) of each exchange to one-party service only.

On June 12, 1980, the Commission received a letter from Mr. George Wilford Arnold, President of the Board of Directors of Logan RTCC, requesting that the Commission's Order be amended to allow the adjusted rates to be charged to customers on each cable route upon completion of such cable routes to one-party service only. Applicant stated that its present financial position requires the implementation of the adjusted rates on the proposed basis.

The Commission, after consideration of the Application, and being advised, is of the opinion and finds that Applicant's request is just and reasonable, and should be approved.

IT IS THEREFORE ORDERED that item No. (3) of the Commission's Order in Case No. 6698, dated March 21, 1977, be and it hereby is amended as follows:

IT IS HEREBY ORDERED that the rates contained in Appendix "A" attached hereto and made a part hereof be and they hereby are designated as the fair, just, and reasonable rates to be applied to the subscribers of the Logan RTCC. Such rates are to be charged to customers on each cable route upon completion of such cable routes to one-party service only, and are to be effective with the first billing date after each cable-


route conversion, with the exception that those subscribers desiring to retain multi-party service shall be allowed to do so and shall be charged the currently prevailing rate for their class of service until no later than December 31, 1981, provided their service remains continuous and unchanged.


IT IS FURTHER ORDERED that Appendix "A" of the above-dated Order is also amended to the extent that the adjusted rates are to be effective to customers upon the conversion of each cable route to one-party service only.

IT IS FURTHER ORDERED that the Applicant shall file with this Commission within thirty (30) days from the date of this Order its revised tariff sheets setting out the changes approved herein.
