AMENDED ORDER

On February 26, 1981, Western Bracken Water District ("Applicant") filed with the Commission its application seeking to increase its existing rates to produce gross annual revenues from water sales of \$65,404, an increase of \$19,638. On June 5, 1981, the Commission entered its Order granting Applicant the proposed increase.

In reexamining the rates set out in Appendix A to the Order of June 5, 1981, the Commission has determined that the rates will not generate the approved revenues. Therefore, the Commission, on its own motion, hereby ORDERS that the rates in Appendix A of its Order entered June 5, 1981, in the above case be, and they are hereby rescinded.

IT IS FURTHER ORDERED that the rates set out in the attached Appendix A are hereby fixed as the fair, just and reasonable rates of Western Bracken Water District to become effective for service rendered on and after June 5, 1981.

IT IS FURTHER ORDERED that the Applicant shall file with this Commission, within 30 days after the date of this Order, its tariff sheets setting forth the rates approved herein.

IT IS FURTHER ORDERED that all other provisions of the Commission's Order entered June 5, 1981, not specifically amended herein, shall remain in full force and effect.
