O R D E R

The Commission, after a review of the responses to requests for information dated April 28, 1981 and May 15, 1981, has determined that some of the responses are incomplete.

IT IS THEREFORE ORDERED that Kentucky Utilities shall file an original and five copies of the following with a copy to all parties of record by June 26, 1981. In the event the requested information is not available, Kentucky Utilities shall state explicitly why that information cannot be furnished. If neither the response nor a motion for extension of time is filed by the stated date, the case will be dismissed.

Order of April 28, 1981

- (1) In response to question 1b, Newton Exhibit 4 does not reflect Net Income.
- (2) The response to Item 4 was not provided according to the format. The list provided does not contain the allocation of these expenses to FERC jurisdiction and to non utility operations. Also, the factor used to allocate was omitted.
- (3) Item 5 does not provide the juristicational breakdown.
- (4) Item 6 does not provide the jurisdictional breakdown.
- (5) In addition to the response provided to Item 10 provide these additional details:

(a) Sheet 5 of 16 - provide the determination of the estimated payroll tax expense effective 1/1/81.

(b) Sheet 6 of 16 - provide the determination of the estimated retirement plan cost effective 1/1/81.

(c) Sheet 7 of 16 - provide the determination of the 1981 estimated premiums for increased medical costs.

(d) Sheet 9 of 16 - provide the determination of the estimated assessed property values at 1/1/81.

(e) Sheet 10 of 16 - provide the following items:

- I. The determination of the 21.06% carrying charge.
- II. The basis for the 10% depreciation rates.
- III. The number of employees for which the labor adjustment was made, their salaries reported during the test year, and their annual salaries.

(6) Item 13a does not include the jurisdictional breakdown.

(7) Item 24 does not include the FERC Rate of Return for each year requested.

(8) The response to Item 24 does not reflect the average rates of return as requested and the work papers were not provided.

(9) Item 40a - coincident peak demand by rate schedule was omitted.

(10) Item 40d - non-coincident and class peak demands by rate schedule was omitted.

Order of May 15, 1981

(1) Item 2 - details were not provided for General Atomic Company and Westinghouse Electric.

(2) Item 3 - the responses to Items 2b and 2d are not satisfactory responses to this question.

(3) Item 4 - the response to Item 2b is not a satisfactory response to this question.

(4) Item 5 - the embedded cost of each component of the Capital Structure was omitted.
